- 1. Use only the enclosed sheets or photocopies of the sheets in submitting your entry. Please be as brief as possible, providing only pertinent information.**
- 2. No additional materials are accepted and will not be considered in judging.**
- 3. The name of your nominee and your local association should be at the top of each page.**
- 4. A 5" x 7" vertical head-and-shoulders photo must accompany your entry. Note the name of your entry and the name of your local association on the back of your photo.**
- 5. Entries should be postmarked by September 28, 2009.**
